(B) Statutory Activities:

Royal Charter Day Date: 09-09-2023

Royal Charter Day was celebrated by organizing a webinar on Google Meet. Er. Rajneesh Kumar, Immediate past Chairman, Meerut Local Centre, in absence of Chairman Er. M.L. Jain, welcomed the guests and members of IEI. Er. Rajneesh Kumar also gave a presentation on Royal Charter. He told about the Royal Charter, brief history and background of IEI Royal Charter and sequence of events which took place during the process of award of Royal Charter to the Institution. He explained the objectives of IEI as incorporated in the Royal Charter and action to be taken to achieve them. He stressed on what is not allowed to be done. Er. Rajneesh Kumar concluded his lecture by explaining how the institution is run.

On this occasion there was a presentation on 'WIET, 6G & IoNT' by Dr. Pragati Sharma, Associate Professor and Head, Department of EEE, Phonics Group of Institution, Roorkee (Keynote Speaker). Dr. Sharma explained the technology of transmission of energy along with information without any interconnecting cables (means wirelessly). 6G is the successor to 5G cellular technology. User data rates are 10 times that of 5G. It has much higher efficiency and connectivity density. IoNT or Internet of Nano things is a technology where nano devices and Internet of Things (IoT) meet. IoNT is essentially a nano scale version of IoT. She discussed in detail how these advancements in technology will further revolutionize the communication.

Er. R.P. Agrawal, Hony. Secretary, IEI, Meerut Local Centre presented the vote of thanks.

Engineers' Day Date:16-09-2023

56th Engineers' Day was celebrated in collaboration with Sir Chhotu Ram Institute of Engineering & Technology, Meerut in their seminar hall. The programme started with the lighting of lamp and presentation of bouquets to Chief Guest and Speakers.

At the outset Er. V.C. Gupta past Chairman, in absence of Chairman Er. M.L. Jain, welcomed the guests, which included faculty and students of SCRIET and members of IEI.

Er. V.C. Gupta,FIE, retd. S.E. UPPCL gave presentation on life sketch of Bharat Ratna Sir M. Visvesvaraya and his contribution to the nation, as a great engineer, an efficient administrator, an eminent statesman, educationist, economist and social worker.

Two speakers delivered lectures on the theme for this year 'Engineering a Resilient Future: Building Stronger, Smarter, Safer'. Dr. Swati Singh, Associate Professor Deptt., of Aplied Science, SCRIET, Meerut started her lecture with a brief introduction of resilient future and various concepts of it such as preparedness for change, adaptability, flexibility, innovations, technology etc, than smart, strong and safe element into engineering solution and their impact with appropriate examples were discussed in detail. Next to it some key principles of resilience were explained namely resilient infrastructure, climate resilience energy and resource efficiency, diverse systems and adaptive urban planning. The pivotal role of an engineer in changing and shaping the future in numerous ways was elaborated by taking three key areas into consideration. The chosen areas were technology advancements, healthcare innovations, space exploration and colonization. Transport revolution, communication urban development, biotechnology and genetic engineering are some of the major innovations that are transforming our world were explained thoroughly.

Ms. Nidhi Bhatia, Assistant Professor Deptt. of Computer Application, discussed Natural Language Processing (NPL) that refers to Artificial Intelligence concerned with giving computers the ability to understand text and spoken words in much similar way human being can. NLP is a machine language technology that gives computers the ability to interpret, manipulate, and comprehend human language. NPL has its applications in Question Answering, Spam Detection, Sentiment Analysis, Machine Translation, Spelling Correction, Speech Recognition, Chatbot, Information Extraction, Text Summarization, Topic Modeling etc. She told that NLP has piromising job opportunities for NLP engineers.

The Chief Guest of the programme, Dr. Niraj Singhal, Director, Sir Chhotu Ram Institute of Engineering & Technology, Meerut said that technology & development are beneficial only if used properly and in a planned manner. Unplanned development/construction in Himachal Pradesh resulted in disaster. Though beneficial, yet artificial intelligence is lessening power as well as necessity of creativity in human beings. The Chief guest and speakers were presented mementoes.

Er. R.P. Agrawal, Hony. Secretary, Meerut Local Centre presented the vote of thanks. News of the celebration of Engineers' Day was published in two leading news papers of Meerut on 17-09-2023.

(C) Lecture Meeting:

By Er. Sanjay Chaudhary on 30-07-2023

A lecture meeting was organized on "Project Management: Trends and Implications on Performance" on 30th July, 2023 at office of Meerut Local Centre. Er. Sanjay Chaudhary B.E.(ECE), M.S.(MIS), MBA Industry Fellow University of Petroleum & Energy Studies, Dehradun was the speaker. The session was started with a welcome note from Er. M.L. Jain, Chairman Meerut Local Centre. Er. Choudhary told that it is estimated that by 2030 India will have more than 1.5 billion people and she will require 4.5 trillion dollars by 2040 to develop infrastructure to sustain its economic growth. According to PMBOK (PM Book of Knowledge) Project Management (PM) is the application of knowledge, skills, tools, and techniques to project activities. Importance of PM for Indian Economy can be realized when we come to know that as on January 2018, 345 government projects have incurred a cost overrun of INR 2.19 lakh crore. PM has a very good future in Engineering as Digitization, Robotization, Artificial Intelligence, IoT, Vertual Reality, 3D etc. are changing. PM is now a tool to implant the strategic changes aimed at adapting to the changes in market. With evolution of approach of PM now there is focus shift from efficient to effective PM. He told that project management information system (PMIS) for teams provide-

- (i) Ease of Communication (Team collaboration software and file- sharing within and across project).
- (ii) Schedule Check (Roadmap with automated follow ups).
- (iii) Ease of Orientation (Streamlined work management features).
- (iv) Record Maintenance (Scrub boards for backlog visibility).
- (v) Linked Information (Real time updates between team members)

In the end, Hony. Secretary Er. R.P. Agrawal delivered vote of thanks.

A lecture meeting was organized online on google meet on "Refrigerants" on 27th August, 2023. Dr. K.L.A. Khan Dean IEC and Professor, Department of Mechanical Engineering KIET Group of Institutions was the speaker. The session was started with a welcome note from Er. M.L. Jain, Chairman Meerut Local Centre. Dr. Khan said that Refrigerant is the primary working fluid used for absorbing and transmitting heat in a refrigeration system. Refrigerants absorb heat at low temperature and low pressure and release heat at a higher temperature and pressure. Most refrigerants undergo phase changes during heat absorption (evaporation) and heat releasing (condensation). Due to several environmental issues such as ozone layer depletion, global warming and their relation to the various refrigerants used, the selection of suitable refrigerants has become one of the most important issues in recent times. The thermodynamic efficiency of a refrigeration system depends mainly on its operating temperature. There are Primary and Secondary refrigerants . Primary refrigerants are fluids which are used directly as working fluids. Secondary refrigerants are fluids which are used for transporting thermal energy from one location to other. They are also known as Brines or Antifreezes. Generally the freezing point of a brine will be lower than the freezing point of its constituents. Essential properties of refrigerants include chemical stability, and latent heat of vaporization.

Refrigerants are Halocarbons (R11, R12 etc.) and chloroflorocarbons called Freons also. He told Inorganic refrigerants include CO2, water, NH3, air, SO2.

He also discussed ozone layer and harmful consequences of ozone depletion on human and plants. He also discussed Montreal Protocol that was signed in 1987 under the 'UNEP' after much discussion. India ratified it on Sept 17, 1992.

In the end, Hony, Secretary Er. R.P. Agrawal delivered vote of thanks.
