Minutes of 9th AGM held online on 24-04-2021 Statutory Compliance of Notice

AUDITOR'S REPORT

1. Report on the Financial Statements

We have audited the accompanying financial statements of the Institution of Engineers (India), Meerut ("the Institution"), which comprises of the Balance Sheet as at March 31st, 2021, signed by us under reference to this report and the related Income and Expenditure Account and the Cash Flow Statement for the year then ended and schedules forming part of the accounts and a summary of significant accounting policies and other explanatory information, in which have been incorporated the returns/ accounts received from the Institution of Engineers, Meerut Local Centre for the year ended 31st March, 2021 as audited by other auditors.

2.Management's Responsibility for the Financial Statements

Management is responsible for the preparation of these financial statements that give a true and fair view of the financial position, financial performance and cash flow of the Institution in accordance with the applicable Accounting Standards issued by The Institute of Charted Accountants of India and generally accepted accounting practices. This responsibility also includes maintenance of adequate accounting records and safeguarding the assets of the Institution and for preventing and detecting frauds and other irregularities, selection and application of appropriate accounting policies, making judgments and estimates that are reasonable and prudent and design, implementation and maintenance of educate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true fare view and are free from material misstatement, whether due to fraud or error.

3. Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit.

We conducted our audit in accordance with the standards on auditing issued by the Institute of Charted Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement. An audit involves performing procedures to obtain audit evidences about the amounts and disclosures in these financial statements. The procedure selected depends on the auditor's judgement, including the assessment of the risk of materials misstatement of the financial statements, whether due to fraud or error. In making those risk assessments; the auditor considers internal financial control relevant to the Institution's preparation of the financial statements that give a true and fare view in order to design audit procedures that are appropriate in the circumstances. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall preparation of the financial statements. We believe that the audit evidence

we have obtained and the audit evidence obtained by the other center auditor's in the terms of their reports is sufficient and appropriate to provide a basis for our audit opinion on the financial statements.

4.Opinion

Our opinion and to the best of our information and according to the explanation given to us, the financial statements give the information in the manner so required and subject to the comments annexed in Annexure-III give a true and fair view in conformity with the Accounting Standards generally accepted in India:

4.1) In the case of the balance sheet, of the state of affairs of the Institution as at 31st March, 2021;

4.2) In the case of the Income and Expenditure Account, of the surplus for the year ended on the date; and

4.3) In the case of the Cash Flow Statement, of the cash flows of the year ended on that date.

5.Report on Other Legal and Regulatory Requirements

- (v). The reports on the accounts of the centers by the audited by the center auditors have been sent to us and have been properly dealt with us in preparing this report;

(vi). We further report that according to the information and explanation given to us:
